FOUR DAYS LEFT TO JOIN AMICUS BRIEF TO U.S. SUPREME COURT

A war is being waged here on Earth. Its soldiers are you and me. Its battlefields are courts, legislatures, and boardrooms. Its weapons are fear, hope, truth, and despair. Its victims are whales, herons, foxes, and bees. The stakes are life itself.

This week is the last opportunity to take sides on one of the most crucial battlefields in this conflict: the Supreme Court of the United States of America. Twenty-five years ago, an incredible law was passed in the United States -- a nation that is supposed to stand for life, liberty, and the pursuit of happiness -- a law was passed that obliterates life, liberty, and happiness. An incredible clause in the Telecommunications Act of 1996 prohibits my government from protecting life, liberty, property, and happiness from the greatest assault this world has ever known. And since the rest of the world, for better or for worse, tends to follow what my nation does, this assault is taking place everywhere on Earth.

The Santa Fe Alliance for Public Health and Safety -- an organization to which I belong -- has succeeded in bringing a challenge to that clause to the doorstep of the U.S. Supreme Court, and we need all the might of your organizations throughout the world arrayed on our side to take advantage of this unique opportunity to stand for truth and hope and against fear and despair. This opportunity will not easily come again, and our planet is running out of time.

There are those among us who, playing on fear, and in service to corporate boardrooms, have been spreading the lie that if the Supreme Court grants our

petition for certiorari and agrees to hear our case, and ultimately rules against us, that that will set a bad precedent, and they have been advising organizations around the world not to join us in this battle for life. Nothing could be further from the truth.

The Supreme Court of the United States receives 3,000 petitions for certiorari each year, and on average only agrees to hear 80 of them. It only agrees to hear cases that bring issues that the Court considers credible and important. The acceptance of our case by the Supreme Court, whether or not we ultimately prevail, will give our cause credibility and publicity, worldwide, that has never been achieved through fear and despair, and that can only be achieved by entering doors that are opened.
