NOTICE OF APPEAL

Notice is hereby given pursuant to NMSA 1978, Section 62-11-1, NMSA 1978, Section 62-10-16, and Rule 12-601(B) NMRA, that New Mexicans for Utility Safety (“NMUS”) appeals to the New Mexico Supreme Court from the *Final Order*, adopted by the New Mexico Public Regulation Commission (“NMPRC”) in Case No. 22-00058-UT on October 17, 2024, and entered in writing in its records. NMUS takes this appeal against the NMPRC. A copy of the *Final Order* is attached hereto as an Exhibit.

Pursuant to ordering paragraph J of the *Final Order*, NMUS timely filed a Motion for Rehearing on November 18, 2024. The NMPRC failed to act on the

Motion for Rehearing by December 9 (within twenty (20) days of filing the motion for rehearing). *See* Section 62-11-1. This Notice of Appeal is timely filed within thirty (30) days after the motion for rehearing was deemed denied by Section 62-10-16. NMSA 1978, Section 62-11-1.
